# Mission Moment: 1,000 Books Before Kindergarten

Mrs. Goyette introduced Elaina Skovira, Buena Vista Branch Manager and asked that she tell about her program in Buena Vista, 1,000 Books before Kindergarten, which encourages parents to read with their children every day.

Mrs. Skovira also offers Kindergarten Preparation classes. She introduced this program three years ago. The program has been so successful it fills up by word of month before she can formally advertise it. The classes are designed for preschool-aged children to help prepare them for Kindergarten in the following year. There is not a program like this in the City of Buena Vista at this time.

Mrs. Skovira was an elementary school teacher before she came to work for RRLS. During Kindergarten Preparation classes, she teaches children how to follow directions, write their name, form a line (they take turns being the line leader), do seat work, and clean up before they go home. Mrs. Skovira uses a room on the second floor of the Buena Vista Library for a classroom. Children completing the classes are prepared for success when they start school. Mr. Behrens asked how many children in the community are not included in this program. Mrs. Skovira said it was hard to know. There is a real need for this program!

#### Goshen lease/System Agreement

All governing localities have approved the System Agreement. We are now waiting for Mr. Harris, Goshen property owner, to get back with us about modifying the lease he presented to a 5-year lease instead of the 20-year lease he wanted.

Mrs. Goyette discussed the reduction of hours at all branches and the cutting of hours of some parttime staff. Buena Vista was the hardest hit with the branch being closed two days a week and reducing their operating hours from 36 hours to now 28 hours a week. All branches are closed on Fridays as it is the least busy day of the week. Lexington will be open on Fridays from 1:00 – 5:00 pm.

Mr. McWilliams asked the trustees to think of how the board can impress on localities the importance of libraries to their communities. They need to be aware of the important value a public library brings to their community.

Mr. McWilliams introduced our new Trustee, Jessica Whipple. Ms. Whipple has a Master in Library Science. She has knowledge of many aspects of a library system. She has recently moved back with her husband to Buena Vista. We are very pleased to welcome her to the Board of Trustees.

Mr. Behrens made a motion to approve the budget as presented. Mr. Bell seconded the motion. The Board voted unanimously to approve the FY 2020 Operating Budget.

#### Slate of Officers

Mr. McWilliams announced the board would continue with our current slate of officers as per our discussion at our last meeting with the exception of finding a new vice chair. Mr. Horan made the motion to approve continuing with our current slate of officers. Mrs. Heslep seconded the motion. The Board voted unanimously to approve this motion.
